**CONDITIONS OF POOL MEMBERSHIP AND CODE OF CONDUCT**

All members are required to present a valid pass card for identification when using ECGS Pool facilities and programs. Membership privileges and cards are not transferable, remain the property of the ECGS, and must be returned upon request. The ECGS reserve the right to refuse or revoke any membership. Membership is continuous based on the method of payment. I agree to return all applicable key cards upon cancellation and understand that I will receive a temporary card for the remainder of my membership for which I have paid or will be paying.

The undersigned understands that the ECGS is NOT responsible for personal property lost or stolen while members and/or program participants are using ECGS facilities or on ECGS premises.

I give my permission to the ECGS to use, without limitation or obligation, photographs, film footage or tape recordings that may include mine and or my family member's image(s) or voice(s) for purposes of promoting or interpreting ECGS programs.

In the event of an emergency and my emergency contact person cannot be reached, the undersigned hereby gives his or her permission to the physician selected by the ECGS to hospitalize, secure proper treatment for, and to order injections, anesthesia or surgery for the individual named on this application.

The undersigned understands that no accident or medical insurance is provided with this activity.

The ECGS conducts regular sex offender screening on all members, participants, and guests. If a sex offender match occurs, the ECGS reserves the right to cancel membership, end program participation, and remove visitation access.

**MEMBER CODE OF CONDUCT**

The ECGS is committed to providing a safe and welcoming environment for all members and guests. The ECGS reserves the right to deny access or membership to any person who fails to comply with safety protocols, policies and procedures that are in place to protect the health and well-being of all.

**To promote safety and comfort for all, all individuals are asked to join us in taking necessary precautions to reduce the spread of COVID-19.**

- If you have a fever or have symptoms of a contagious illness, please stay home until you are well.
- Keep at least 6 feet distance between yourself and others while at the ECGS.
- Wash hands frequently and use provided sanitizer before and after swimming.
- Wipe down equipment with provided disinfectant wipes before and after use. Place equipment in areas designated for equipment that needs additional sanitization.
- We recommend wearing face masks in close proximity to others, except when swimming in the pool.

**We expect everyone using the ECGS to act maturely, behave responsibly and respect the rights and dignity of others. Below is a list of prohibited actions, but the actions listed below are not an all-inclusive list of behaviors considered inappropriate in our facilities or programs.**

- Agree to the Pool Rules which are posted in the Pool Area, Locker Rooms and Lobby.
- Carrying or concealing a weapon or any device or object that may be used as a weapon on ECGS property or at ECGS programs
- Agree to swim at your own risk. No lifeguards are available. I understand that floatation equipment, toys, and exercise equipment available for use at the pool are not approved lifesaving devices and cannot compensate for any inability to swim. I further understand that all non-swimmers are required to provide and wear a Coast Guard approved swim vest, or to remain in shallow water.
- Using or possessing alcohol or illegal substances on ECGS property or at ECGS programs
- ECGS is a smoke-free environment
- Harassment or intimidation by words, gestures, body language, or any type of menacing behavior
- Physical contact with another person in an angry, aggressive, or threatening way
- Verbally abusive behavior, including angry or vulgar language, swearing, name-calling, or shouting
- Sexually explicit conversation or behavior; any sexual contact with another person
- Inappropriate, immodest, or sexually revealing attire
- Theft or behavior that results in the destruction or loss of property
- Loitering within or on the grounds of the ECGS

The ECGS reserves the right to deny access or membership to any person who has been accused or convicted of any crime involving sexual abuse, is or has been a registered sex offender, has ever been convicted of any offense relating to the use, sale, possession, or transportation of narcotics or habit forming and/or dangerous drugs, or is presently or habitually under the of dangerous drugs or chemicals, narcotics or intoxicating beverages.
